TERMS AND CONDITIONS ON SKIP BINS

Introduction

Please read these terms of use carefully. By accessing our site or using our services, you acknowledge that you understand, agree, and are bound by these terms.

1. Submitting an Order

Submitting an order to West Coast Council constitutes an offer to enter a contract for the provision of skip bin services with West Coast Council.

2. Skip Bin Ownership

All skip bins hired by West Coast Council to the client will remain the property of West Coast Council during the period of the hire contract. The client will have no right to claim ownership and will have no interest in the skip bin once the hire contract has been completed.

3. Price

All prices include delivery/removal and lifts of skip bins as per the current fees and charges stated on the Council web site. Charges are updated on an annual basis.

Once a quoted order is confirmed, the price of the goods and services stated cannot be amended unless West Coast Council has expressly agreed in writing to that variation.

4. Access and Ground Conditions

West Coast Council accepts no liability for any property damage during bin delivery and pickup. It will be the responsibility of the customer to ensure that the area chosen for placement is suitable for the skip bin.

5. Do Not Overfill or Overload

YOU AGREE TO ONLY FILL EACH HIRED SKIP BIN BENEATH THE TOP RIM OF THE SKIP BIN OR TO THE FILL LINE MARK OF YOUR ORDERED BIN SIZE. Any overfill waste will incur a surcharge to be added to your order.

6. Alternate Supply

You accept that if we do not have the required Skip Bin available based on your requirements, then in consideration of the order you make to West Coast Council you agree for us to supply you with an alternate size Skip Bin suitable for the same (or similar) purpose, or we will arrange for delivery when we have the right size skip bin for you.

7. Restricted Waste and Hazardous Waste

You agree that in accordance with relevant Australian environmental laws including EPA Schedule 7 that you must not place any restricted waste inside the hired Skip Bin: **NO ASBESTOS, NO TYRES, NO LIQUID OR HAZARDOUS WASTE, NO BATTERIES, ACID OR FULL PAINT TINS, SYRINGES AND GAS BOTTLES.** If any of these items are in the bin the customer is responsible to empty these items out of the bin. If customer cannot be reachable West Coast Council will notify the EPA that the skip bin came from your address and will be liable for disposal costs and incur sever fines.

8. Payment

A tax Invoice will be issued to client once collection/inspection has occurred. Payment is to be made as per payment terms stated.

9. Burning Items in Skip Bin or Missing Skip Bin

Under no circumstances are items in the skip bin to be incinerated. Any damage caused by fire will be passed on to the client.

Under no circumstances customer cannot call or let any other skip bin company to pick up West Coast Council bin, any skip bins that are missing on the time of pick up the client will be responsible and liable for costs involved.

10. Order Cancellation and Variation

The client will be entitled to cancel or vary an order provided that West Coast Council receives notice of cancellation or variation no later than two working days prior to the delivery date. Any other variation to your order will be at West Coast Council discretion.

11. Waste

West Coast Council reserve the right to charge the client directly for any fees incurred for incorrect waste or excess weight that has been placed in the bin. Please insure you place the right waste that you originally ordered.

The driver has the right to ask the client to check his waste upon delivering the skip bin and at his discretion he has the right to let the client know how much extra charges it will be if wrong contents are place in the bin. If the client does not co-operate the driver has the right to cancel the bin.

If upon pick up and the driver sees that the wrong waste has been placed in the bin and client does not co-operate or cannot be reachable to pay the extra charges, the driver will not empty the skip bin until those items are removed. If any unseen items damaged West Coast Council property the client will be liable for those damages.

12. Sole Responsibility

You agree that you are solely responsible for the hired Skip Bin upon delivery of the Skip Bin at the delivery site.

13. Delivery

West Coast Council is committed to getting the job done, we cannot give you a time on the day of Delivery due to the Logistics of the business, which sometimes could be out of our control. A site inspection will be done prior to your delivery to ensure location is suitable. If site is not suitable the client will be notified so other options can be found. For deliveries out of service areas a surcharge will apply at a per visit charge.

14. Termination

West Coast Council reserves the right to terminate access to our services and block future use if we deem these Terms of Use have been violated **ANY BREACH OF THE ABOVE TERMS AND CONDITIONS MAY RESULT IN ADDITIONAL CHARGES.**
